AmeriCorps program: The South Carolina Commission on National and Community Service, a program of the Association by executive order (2007-24) by Governor Mark Sanford, is the Palmetto State's lead agency for community service and volunteerism, informing the public of the value of and need for greater community service and volunteerism, calling upon all South Carolinians to become involved in community service, and partnering with the public, private and not-for profit sectors to increase resources and create more opportunities for service and volunteerism. We made more than \$1,400,000 of grants in 2008-2009 to establish AmeriCorps programs which meet these goals, focusing especially on increasing high school graduation rates and increasing financial stability for low-income working families. Funding for these programs comes from the Corporation for National and Community Service. On-going technical assistance is provided for our AmeriCorps partners.
